If a person or public body does not make oral or written submissions at a public meeting, or make written submissions to the Town of Deseronto before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal (LPAT).

If you wish to be notified of the decision of Council in respect to any of the applications, you must submit a written request to the Clerk.

The Clerk must provide notice of council's decision to all those who request a copy within 15 days after the day the by-law is passed. Anyone may appeal the decision to the LPAT by filing with the Clerk within 20 days of the notice of decision.
