- Ensure that Wages and Employee Benefits only include 2 students
- Clarify which buildings are included under Building Maintenance
- Have 2 port-a-potties installed for the summer
- Reduce Equipment Maintenance to \$800.
- Increase Fountain Maintenance to \$500
- Reduce Overall Budget Request to \$40,000.

RECREATIONAL PROGRAMS

- Reduce Golf Tournament Expense to \$4,500.
- Reduce Baseball Revenue to \$3,000.
- There is no line item for a Canada Day grant
- Investigate creating a service agreement with the Library to offer summer programming for children at a fee of \$2,500.
- Reduce Overall Budget Request to \$

ARENA

- Reduce Wages down to \$100,000.
- Reduce Employee Benefits appropriately
- Reduce Office Supplies to \$1,000.
- Reduce Office Equipment to \$1,000.
- Reduce Hydro to \$95,000.00 and encourage staff to turn lights off at night
- Remove Pick-up Truck from Capital Budget
- Remove Heating Unit from Capital and increase rental rate to cover heating unit
- Remove TAZ Machine from Capital Expense and rent the unit instead
- Reduce Ice Rental Fees to \$115,000.
- Increase Building Rental Fees to \$13,000.
- Increase Bar Revenue to \$12,500.
- Staff are encouraged to hit Revenue Line items
- Further clarification is required on Ice Plant Maintenance, Equipment Maintenance, Mileage/Travel/Training, Equipment Rentals, Safety Supplies, and Beverage Costs
- Reduce Overall Budget Request to \$270,000.
