6. Request from the Deseronto Business Association

Council discussed the financial request and was not in favor of paying for newsletters or bulletins

7. Request from the Deseronto and District Historical Society

Council requested that J. Zieman be asked to submit a request for funding for a specific project along with a budget and follow-up with a wind-up financial report

8. Demolition of a property

Council requested that Administration staff ask Frontenac to obtain a quotation to fill with clean fill rather than the concrete being left in the ground.

9. Quinte Conservation grant opportunity

Council advised that Quinte Conservation should go ahead and apply and further that a final decision could be made later.

10. My-FM Advertising

Mayor Clark advised Council that he had spoken to My-FM and they had an advertising package that would permit short ads 2-3 days per week. It would also allow for Council decisions to be included on their news feed and items advertised on their website. The cost for the package was approximately \$2,500.00 for the year. It was felt that the cost could be split among several departments.

11. 2018 Budget -

Council reviewed the budget and made the following comments/changes:

Fire Department

- W. Bouma was able to reduce the budget request to \$180,000.
 - by:
 - Reducing Wages by \$1,000.
 - o Reducing Employee Benefits by \$500.
 - o Reducing Gasoline/Oil Trucks etc. by \$200.
 - o Reducing Fire Mutual Aid Meeting Costs by \$100.00
 - Reducing Radio Licences by \$100.
 - o Reducing Hydro by \$600.
 - o Reducing Education by \$500.
 - Removing the Jaws for Life from Capital Expenditures (\$15,000.)
 - Increase Sundry Revenue to \$250.00

Public Works - Roads

- W. Bouma was able to reduce the budget request to \$480,000. by:
 - o Reducing Wages down to \$184,000.
 - o Reducing Employee Benefits to \$49,700.
 - Leaving Office Supplies at \$900.
 - o Reducing Materials Cold & Hot Patch to \$20,000.
 - o Reducing Materials Signs to \$3,500.
 - o Reducing Materials Sand/Salt to \$25,000.
 - o Reducing Tree Removal to \$7,200.
 - Leaving Building Supplies at \$5,000.
 - o Reducing Truck & Equipment Maintenance to \$24,000.
 - o Leaving Truck Licences at \$3,800.
 - o Reducing Small Tools to \$1,500.
 - Leaving Training at \$4,500.
 - Removing Leaf Vacuum from Capital –Vehicles (\$20,000.)
 - o Reducing Capital Repairs Sidewalks to \$25,000.
 - o Inserting \$13,000. Expense for 2017 budgeted repairs
 - Inserting \$13,000. In Reserves Transfer for 2017 budgeted repairs

Parks

W. Bouma was able to reduce the budget request to

\$40,000. by:

- Reducing Wages to \$25,000.
 - Reducing Employee Benefits to \$4,500.

- Reducing Building Maintenance to \$1,000.
- Reducing Equipment Maintenance to \$800.
 - Inserting \$500. For Fountain Maintenance

Recreational Programs

- W. Bouma was able to reduce to budget request to \$17,500. by:
 - Remove Wages
 - Remove Employee Benefits
 - Reduce Golf Tournament Expense to \$4,500.
 - Add \$2,500 for Library Summer Programming
 - Reduce Baseball Revenue to \$3000.

Arena

- W. Bouma was able to reduce to the budget request down to \$295,400. by:
 - Reducing wages down to \$100,000.
 - Reducing Employee Benefits down to \$22,000.
 - Reducing Office Supplies down to \$1,000.
 - Reducing Office Equipment down to \$1,000.
 - Reducing Hydro down to \$95,000.
 - Reducing Heat down to \$13,000.
 - Reducing Capital Expense Equipment to \$54,000. (remove truck, heater and TAZ floor cleaner)
 - Increase Building Rental to \$13,000.
 - Increase Bar Revenue to \$12,500.
- Further reductions are required to bring it down to \$280,000.
