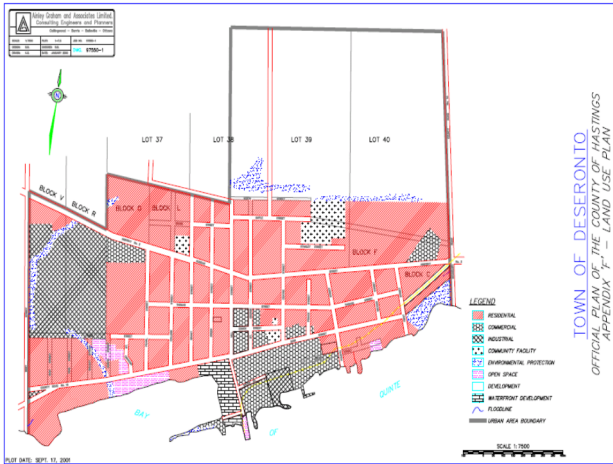


NOTICE OF SUBMISSION OF TERMS OF REFERENCE
Corporation of the Town of Deseronto Waterfront Development Project



As part of the planning process for the Waterfront Development Project, a terms of reference was submitted to the Ministry of the Environment for review as required under the *Environmental Assessment Act*. If approved, the terms of reference will serve as a framework for the preparation and review of the environmental assessment for the proposed undertaking.

The undertaking will consist of determining the best location for building a municipal boating marina somewhere along the shoreline of Deseronto within the limits of the town.
